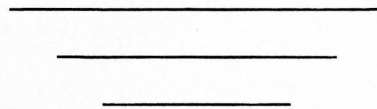

FOREWORD

This list includes all of the visiting Fulbright-Hays scholars in the United States during the 1965-66 academic year who have informed the Conference Board Committee that they will be available for occasional lectures. It has been prepared as a supplement to the Directory of Visiting Scholars in the United States under the Fulbright-Hays Act in order to provide more detailed information regarding the scholars interested in this type of activity, including the topics on which they are willing to speak.

The list is arranged by geographic areas of the world, with the home country of each scholar, as well as his field of specialization, indicated. This classification has been followed since many of the scholars are willing to speak on general topics relating to their own national culture and history, rather than or in addition to, their field of academic specialization. If further information is desired as to whether a scholar would be a suitable speaker for a specific occasion or group, it is suggested that the indicated faculty associate or head of the sponsoring department be consulted before an invitation is extended. For example, some scholars might be more effective with small groups and in seminars than with large audiences. It should also be noted that the scholar's facility in the use of the English language may, in some cases, be limited.

Although most of the scholars hold teaching or research positions at their host institutions and may have limited time available for visits to other institutions, they would, in most cases, be able to arrange their schedules to permit brief absences. It would be appropriate to write directly to the scholar in care of his faculty associate or department at the host institution as indicated on the list. Letters may also be addressed to the scholars in care of the Conference Board Committee. It is hoped that any scholar invited to speak would be reimbursed for his travel and other expenses. An honorarium, even though modest, would also be appreciated.

The Committee regrets that it is not possible to make this list available at an earlier date. Most of the visiting scholars do not reach the United States until September and it is not usually possible for them to plan their schedules for visits to other institutions prior to their arrival.

It is important that the Committee be sent a copy of any invitation extended to a visiting scholar. A brief report on his visit would also be helpful in order to determine the usefulness of this type of list.

He is especially known for his studies of Dogen and Shiuran. Professor Abe also participated in the International Congress of the International Association for the History of Religions, held at Claremont, California, in September 1965. He has published many articles on Buddhism and Christianity, as well as on Kant's philosophy.

PROCEDURES FOR OFFERING APPOINTMENTS TO FOREIGN SCHOLARS UNDER THE
FULBRIGHT-HAYS ACT

Awards to foreign scholars under the Fulbright-Hays Act are administered in cooperation with binational Commissions/Foundations or United States Embassies in the participating countries. Travel grants may be awarded for an initial period of not less than three months nor longer than one year to supplement stipends provided by American universities for lecturing or research appointments. Under certain specified conditions, the tenure of the grant may be extended to permit a scholar to remain in the United States two years and, under exceptional circumstances, an extension for a third year may be approved for a scholar engaged in research. Travel grants for lecturers, however, are limited to a maximum of two years.

The following procedures are outlined for American institutions wishing to offer a lecturing or research appointment to a foreign scholar under the sponsorship of the Fulbright-Hays exchange program.

(1) Direct Invitation to a Foreign Scholar

If an American university knows a particular foreign scholar it wishes to appoint on a temporary basis, an invitation may be extended directly to the scholar, and he can be advised to apply for a travel grant through the binational Commission/Foundation or the United States Embassy in his own country. The letter of invitation should indicate the nature of the desired assignment, the period of time to be spent at the university, and the salary to be paid. This letter will be attached to the scholar's application as evidence of his dollar support and institutional connection in the United States.

(2) List of Foreign Scholars Available for Remunerative Appointments

Each year a number of foreign scholars are nominated provisionally by the binational Commissions/Foundations abroad for travel grants on condition that remunerative teaching or research positions will be offered them by educational institutions in the United States. A list of these scholars is prepared by the Committee on International Exchange of Persons early in the calendar year and contains brief biographic data regarding each scholar. The Committee will be pleased to mail this list, upon request, to any interested institutions.

(3) Announcement of Positions Available for Foreign Scholars

If a university wishes the assistance of a binational Commission/Foundation abroad in finding a qualified candidate for a particular research or teaching position, a letter to this effect should be sent to the Committee on International Exchange of Persons. A form indicating the information required from the university and the binational Commissions which are willing to offer this kind of assistance will then be sent. Such requests should be made well in advance and only when a university seriously wishes a foreign scholar to fill a position and is willing to hold it open for a minimum period of three months so that the Commissions/Foundations will have sufficient time to explore the availability of qualified candidates and submit their application papers.
